I agree to pay \$ 60 per month in SNAP benefits from my June 2021
or(starting month) benefit issuance through my October 2021 issuance for a
Regular Summer Veggie Share (average of 8-13 items per week).
OR
Partial Payment with SNAP Benefits:
I agree to pay \$ in SNAP benefits per month from my June 2021 or
(starting month) benefit issuance through my October 2021 issuance as a partial payment towards the total monthly cost of my CSA share for a <i>Regular Summer Veggie Share</i> average (\$60.00 per
month). I will pay the remaining balance \$ to Lexington Community Farm with a check or money order.
If I cannot pay the full balance of my CSA share, <i>Lexington Community Farm</i> will change the amount of produce in my share, equal to the amount of what was deducted from my SNAP benefit.
II. I understand that:
☐ The amount I agreed to above will be automatically deducted from my EBT account on the date that I receive my SNAP benefits.
☐ I will receive farm produce weekly, which will be available for pick up 52 Lowell Street, Lexington, MA Wednesday1-6pm and Thursday 3-7pm OR Friday 1-6 pm and Saturday 9-1
☐ It is my responsibility to pick up my share on my scheduled pick-up date, during the scheduled pick-up time.
☐ If I cannot pick up my share, it is my responsibility to have someone to pick it up for me.
☐ If I do not pick up my share during my scheduled pick-up time, it will be donated to a local food pantry, shelter or other institution that will make use of the produce and <u>I will not get a refund</u> .
☐ The types of produce in my share will change weekly. There is no guarantee on the exact amount of produce. Shares will vary in weight, size and type of produce.
$\hfill\Box$ I cannot return my CSA share for a refund or exchange it for other produce.
☐ I can cancel my participation in the pilot at any time. If I no longer want to participate, I will ask Lexington Community Farm or call DTA at 413-772-3411 for a cancellation form.
